Committee/Event Reports:

Treasure's Report: Billy Pyeatt – The Treasures report was presented by Billy Pyeatt and filed for Audit. Currently the bank balance is \$57437.38.

Audit Committee: Steve Broeder – Audit Committee met January 14, 2022, to finalize the 2021 audit. The Audit found no exceptions.

Membership Committee: Heather Baker – Currently there are 161 members. The next meeting will be January 25. Class 53 will be offered membership at the week eight of their class.

Pear Run Committee: Billy Pyeatt – This year the Pear Run will be held at Independence Park on May 7, 2022. The City has waved all fees. This saves \$1500 which is the fee for the Town Center.
